# COMMUNICATIONS & ELECTRONICS WEEK 2019

1. Officers and NCMs of the C&E Branch and its founding services: this letter and the affixed enclosures provide an overview of C&E Week 2019. Note that this year's event will deviate from previous iterations. I am concentrating staff efforts needed to update a range of outmoded orders and directives which collectively imbue our Branch with custom, tradition, history, and authority. Updating these documents shall represent the focus of my efforts for C&E Week 2019.

2. <u>Event Overview</u>. C&E Week will span **Monday**, **21 October 2019** to **Friday**, **25 October 2019**. CFB Kingston will host all events save for a singular exception – the RCAF A6 CAPCON – which will reside in CFB Trenton. The enclosed schedule details the timings and venues for all sanctioned events. The synopsis for C&E Week 2019 is as follows:

- a. <u>Sergeants' & Subalterns' Indoctrination Programme</u>. A two (2) day PD course for junior officers (2<sup>nd</sup> Lieutenants and Lieutenants), newly promoted Sergeants, and those Master Corporals set for promotion to Sergeant this year. The course now meshes both NCM and commissioned audiences and will cover Branch / Corps history, matters pertaining to etiquette and protocol, roles & responsibilities, and discussions regarding command team principles in both operational and garrison settings;
- b. <u>Exercise NOBLE SKYWAVE</u>. The annual international High Frequency (HF) communication competition entailing participation from a range of allied partners;
- c. <u>C&E Branch Mess Dinners</u>
  - (1) C&E Officers' Mess Dinner at the Vimy Officers' Mess; and
  - (2) C&E Senior NCMs' Mess Dinner at the Warrant Officers' & Sergeants' Mess.
- d. <u>Environmental Conferences</u>
  - (1) Army G6 Conference (CFB Kingston, ON); and
  - (2) RCAF A6 CAPCON (CFB Trenton, ON).
- e. <u>Major Carruthers Gravesite Ceremony</u>. To respect the founder of the first-ever signalling corps in the British Empire, a solemn gravesite ceremony lead by the CFJSR will take place at the Cataraqui Cemetery in the West-End of Kingston Ontario (927 Purdy's Mill Road, Kingston, Ontario) on the Anniversary of the Corps: the 24<sup>th</sup> of October;

- f. <u>Working Groups (WG)</u>. The main effort of C&E Week 2019 with membership into these committees already confirmed via separate correspondence. Working Group participants are comprised of both serving and retired personnel holding ranks at the Field Officer and Warrant Officer levels. Staff work shall commence prior to C&E Week with the 21<sup>st</sup> to 25<sup>th</sup> of October affording members the opportunity to compile resources and deliverables together for submission. On **Wednesday, 23 0800 October 2019**, I will host an **Opening Address** in the **Reading Drill Hall (RDH)** so as to clearly explicate my intent:
  - (1) WG 01 Branch Standing Orders Update;
  - (2) WG 02 Strategic Outlook and Event Management; and
  - (3) WG 03 Governance Structure.
- g. <u>Annual C&E Honours & Awards Ceremony, and the Branch Update</u>. C&E Week will conclude with the H&A ceremony and Branch Update. The list of speakers can be found within the enclosed documents. Overall, this final component shall confirm the Member and Subaltern of the Year, bestow deserving members with heritage awards, and apprise all attendees on Branch initiatives and the state of the trade via briefings from the senior trade advisors and leaders within our community.

3. <u>Funding and Seating Allocations</u>. Upon approval, the event status – endorsed by ADM(IM) – grants authority for L1s to spend a portion of the overall amount for their respective members. Details can be found in the chart below. In addition to a spending limit, there is also a participant cap to ensure spending does not exceed the authorized amount. L1s are requested to make maximum use of units in the Kingston area for the Sergeants' & Subalterns' Indoctrination Programme to keep costs manageable. Rations (Routledge Meal Hall) and Accommodations (Captain Dawe Building) have been reserved (see below for confirmation code and contact details) by the Branch Adjutant. Your administrative staff may contact his office should you require any details, otherwise state that the requirement is for C&E Week 2019 and reference the confirmation code below when arranging R&Q through base accommodations:
